Role profile

Assistant recording technicians work as part of a small team within a studio environment of a large or small broadcast and/or production company that edits and produces music and sound content before releasing it across multiple platforms, including TV, radio, film and computer games. This role supports more experienced and senior audio or recording engineers to produce high-quality recordings by working with the technical aspect of recording and using various technological tools.

The apprenticeship process

The apprentice will typically spend 24 months on their apprenticeship when they will build their portfolio. Apprentices working 30+ hours a week will spend a minimum of 20% (ie six hours a week) of their time off-the-job, at a training provider, college or with the employer. After 24 months, the apprentice will begin their end-point assessment (EPA) to check they have the knowledge, skills and behaviours required for this role. This assessment should be completed within four months and will be conducted by AIM's specialist end-point assessors.


Gateway

At the end of the formal training period, the apprentice, training provider, and employer will agree the apprentice met the knowledge, skills and behaviours required for this standard. The criteria for these are set by industry and can be found on www.instituteforapprenticeships.org

Apprentices must have the following before Gateway:

- Level 2 English and maths
- A completed portfolio of evidence




Assessment methods

Used for evidencing the knowledge, skills and behaviours (KSBs)

Project report, and presentation with questioning

A project report based on a real workplace recording project, a presentation of the project with questioning from an assessor.



Professional discussion

A structured discussion between the assessor and apprentice, underpinned by the portfolio.



Preparation and support

Before Gateway, AIM will approve the suitability of the apprentice's recording project and establish time frames for everyone to work to. AIM also provides guidance and preparation documents for the assessment and offers online EPA support clinics for the employer, and for the apprentice. Results and certification

The project report, presentation with questioning, and professional discussion will be marked by our industry specialist assessor. The apprentice will receive their grade (distinction, pass or fail) and summary feedback within 15 working days from their last assessment.
